 Update on the Innovation Campus – Lance Collins, Vice President and Executive Director of the Innovation Campus, briefed the Board on recent activities, including the recent, historic gift from Boeing, strides being made to recruit a diverse student body, and plans for faculty, curriculum, facilities, and staffing. Presentation on Research – Dan Sui, Vice President for Research and Innovation, provided an overview of the research enterprise, the current status, and strategic priorities.
