WHEREAS, he participated in numerous study abroad programs in Europe, guiding architecture students to better understand their place in the world; and

WHEREAS, he produced numerous graphic designs including posters, award certificates and compact disc album covers for the Audubon Quartet; and

WHEREAS, he published scholarly articles on the ideas of symbol and model; and

WHEREAS, he dedicated his deep capacities as a scholar in support of the primary teaching mission of the university.

WHEREAS, he sustained his considerable energy and intelligence in support of the primary teaching mission of the university.
